### 5. Counter-Notice

- your name, address, and telephone number;
  
- a statement consenting to jurisdiction in the appropriate federal district court (or if outside the U.S., in an appropriate U.S. judicial district), and that you will accept service of process from the complaining party.

Send counter-notices using the same contact details above.

### **6. Repeat Infringers**

In appropriate circumstances, we may disable or terminate accounts that repeatedly infringe the intellectual property rights of others.

### **7. Misrepresentations**

Please do not submit false or misleading notices or counter-notices. Misuse of the DMCA process may result in liability.
